Subject: - Work Order

8. Cost of all tests recommended shall be borne by you.
9. For the execution of the works, please contact **Site Engineer, RBS, Infra-Division**.
10. The contractor should prepare and submit the actual work plan so as to enable and follow the smooth strategy of construction work and complete on time.
11. The contractor is responsible for insurance as per the insurance norms. Any type of liabilities due to your work will not be borne by the Phuentsholing Thromde
12. If the public properties are damaged during the time of the execution of the work by contractor, the firm is fully responsible to carry out all the rectification on their own expense.
