1. The Royal Government of Bhutan has received financing from the Asian Development Bank (ADB) toward the cost of **South Asia Sub Regional Economic Cooperation (SASEC) Transport, Trade Facilitation and Logistics Project**. Part of this financing will be used for payments under the Contract named above.

2. **Phuentsholing Thromde** (the Purchaser), invites sealed bids from eligible bidders for the **Procurement of Laden Container Lifter and Reach Stacker for the Mini Dry Port in Phuentsholing**.

3. **National Competitive Bidding (NCB)** will be conducted in accordance with ADB's Single-Stage: Two-Envelope bidding procedure and is open to all bidders from eligible source countries of the ADB as defined in the Bidding Document.

4. Only eligible bidders with the following key qualifications should participate in the bidding:

- a. Successful completion as main supplier within the last 3 (Three) years, of at least 1 (One) contracts each valued at 50% with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).
- b. The Bidder shall demonstrate that the goods offered have:
 - i. been in production for at least 3 (Three) years, and
 - ii. been sold a minimum of 4 (Four) units of similar type and specification over the last 3 (Three) years, and
 - iii. been in operation for a minimum of 2 (Two) years.
- c. The Bidder or manufacturer shall demonstrate that it can supply the type, size, and quantity of the goods as required by Purchaser in accordance with the Delivery and Completion Schedule in Section 6 (Schedule of Supply).
- d. Submission of audited financial statements or, if not required by the law of the Bidder's country, other financial statements acceptable to the Purchaser, for the last 3 (Three) years to demonstrate the current soundness of the Bidder's financial position. As a minimum, the Bidder's net worth for the last year calculated as the difference between total assets and total liabilities should be positive.

- e. Minimum average annual turnover of USD 0.75 million calculated as total payments received by the Bidder for contracts completed or under execution over the last 3 (Three) years.

 - Pay a non-refundable fee of Nu. 2,000/- or USD 35/- by cash or draft in favor of **Project Director, Phuentsholing Thromde** between 09:00 hours to 16:00 hours on any working day from **14/02/2020 till 13/03/2020**.

Technical bids will be opened on 13/03/2020 at 2:30 PM (Bhutan Standard Time) in the presence of Bidders’ representatives who choose to attend, whereas the Financial Bids shall remain sealed and unopened and shall be placed locked. The Financial Bids of only Technically Responsive and Qualified Bidders shall be opened after Technical Bid Evaluation, whereas, the Financial Bids of those Bidders who’s Technical Bids are not responsive and qualified shall be returned unopened after the contract is awarded.
