

1. The Royal Government of Bhutan has received financing from the Asian Development Bank (ADB) toward the cost of SASEC Road Connectivity Project. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The Phuentsholing Thromde (“the Employer”) invites sealed bids from eligible Bidders for the construction and completion of Land Customs Station at Ahlay, Pasakha (“the Works”).
3. Open competitive bidding will be conducted in accordance with ADB’s Single-Stage: One Envelope procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - 4.1 **Financial Requirement:** Minimum Average Annual Construction Turnover (AACT) of **Nu. 55.03 million** in the last three years
 - 4.2 **Financial Resource Requirement:** Financial Resources, less its financial obligations for current contract commitments of **Nu. 13.76 million**
 - 4.3 **Construction Experience in Contracts of similar size and nature Requirement:** Participation in at least one contract that has been successfully or substantially completed within the last five years and that is similar to the proposed work, where the value of Bidder’s participation exceeds **Nu. 22.01 million**.
 - 4.4 **Construction Experience in Key Activities Requirement:** (i) Completed construction of at least one G+1 building in the last five years, and (ii) Completed construction of at least 3 km of road works in the last five years
 - 4.5 **Project Personnel Requirement:** (i) Project Manager with Bachelor’s degree in Civil Engineering (or others) -1 No. (ii) Project/ Road Engineer with Bachelors in Civil Engineering (or Diploma) – 1 No. (iii) Electrical Engineer with Diploma in Electrical Engineering - 1 No. (iv) Surveyor with Certificate in Surveying – 1 No. (v) Site Supervisor, a VTI graduate or Class XII graduate – 1 No
