Terms & conditions

1. All the bidders will have to pay the entrance fee of Nu. 500.00 (Ngultrums Five Hundred), which is non-refundable.
2. Each bidder will have to deposit an earnest money of Nu. 5,000.00 (Five Thousand) only for those bidding for the Office equipments
3. On receipt of the entrance fee of Nu. 500.00 and earnest money of Nu. 5,000.00, token card with number will be issued for identification of the qualified bidders. No person shall be allowed to bid in the auction without a token number.
4. The highest bidder, whose bid will be accepted by the auction committee, should deposit a spot payment of 20% of the total value of the auctioned item at the fall of the hammer. The balance 80% payment shall be deposited within 15 (days) days from the day of the auction and before taking delivery of the lots won, failing which the accepted bid will be cancelled and the 20 % spot payment deposit earlier shall forfeit. Should the highest bidder, after acceptance of his bid by the auction committee, withdraw his offer or refuse to make spot payment of 20% at the fall of the hammer, his/her earnest money shall be forfeited and the bidder shall not be allowed to bid for the remaining item/lot.
5. The earnest money of the highest bidder shall be retained until the auction is completed as security for subsequent bid/bids to be offered by him in respect of the remaining items. If the bidders so wishes, the earnest money could be adjusted against the spot payment of 20% or subsequent payment of 80% of the value of lots won by him/her. The earnest money of unsuccessful bidders shall be refunded immediately after completion of the auction.



The highest bidders, whose bid will be accepted by the auction committee, will have to take delivery of the auctioned item at his/her own cost within 15 (days) days from the date of the auction against full payment of the auctioned value in cash or demand draft drawn in favor of Executive Secretary, Phuentsholing Thromde. Failure to do so will result in the forfeiture of the deposit and the item being deposited in the next auction.
7. Phuentsholing Thromde will also not be responsible for any items that have been paid for, but not cleared within 15 days, from the date of the auction.
8. Inspections of the obsolete item(s) shall be allowed strictly from **25th April to 3rd May 2022** during the office hours. No inspections shall be allowed thereafter. Complaints of any mismatch of the condition of obsolete items will not be entertained later.
9. It will be assumed that interested parties bidding for these items would have inspected these lots prior to the auction and that the bid offered is at their own liberty and judgment.
10. The auction committee reserves the right to reject or accept any or all of the bids on the spot or at the subsequent date without assigning any reason thereof. In case of any dispute or problem with regard to the auction, the decision of the auction committee shall be final and binding.
11. Other terms & conditions shall be as per the Property Management Rules and Financial Manual of the Thromde.
