10. The contractor shall prepare the work program/plan for the execution of the work, which should be submitted to employer not later than 10 days after the commencement date.
11. The defect liability period shall be **(7) months** after the completion of the work, as reflected in the tender document.
12. The contractor is responsible for insurance as per the insurance norms. Any type of liabilities due to your work will not be borne by the Phuentsholing Thromde.
