



5. Samples of all materials to be used for the work shall need approval of the site engineer/ employer before the materials are brought to site.
6. You are not allowed to sublet the work.
7. You will mobilize all facilities at site as per the terms & condition of the contract, until completion of work.
8. An initial advance (Mobilization Advance) of 10 % of the bid amount will be given upon a request. However, the payment will be made only upon submission of an unconditional Bank Guarantee equivalent to the advance amount requested.
9. The contractor shall be responsible for setting out the works and ensuring correctness of the positions, level, dimensions and alignment of the works.
10. The contractor shall prepare the work program/plan for the execution of the work, which should be submitted to employer not later than 10 days after the commencement date.
11. The defect liability period shall be (12) twelve months after the completion of the work, as reflected in the tender document.
12. The contractor is responsible for insurance as per the insurance norms. Any type of liabilities due to your work will not be borne by the Phuentsholing Thromde.
